ABOUT MODEL ASSEMBLY

Since 1946, Model Assembly has grown from a simple program featuring only a model legislature and a Youth Governor to an incredibly realistic and complex simulation of the Minnesota state government. Approximately 1,600 students in grades 8 – 12 take part in Model Assembly every January.

Model Assembly is an experience like no other. Each year, students come together and are inspired, connected, and empowered. They get involved with the processes of Minnesota government, learn about issues, meet new friends from all over the state, and have fun the whole time.

FAQS FREQUENTLY ASKED QUESTIONS

Who runs the program?

Student officers who are elected during the previous program year run Model Assembly (MAS). YMCA staff members, teachers, alumni, and volunteers are always present to guide from the side and

help things run effectively. Students are involved in the leadership of YIG programs in meaningful and hands-on ways.

How does conference preparation happen?

Local delegation meetings are the place where students write preparation materials for their program area, listen to speakers and practice their presentation skills. In November, delegates from all over the state come together for intensive training called LAUNCH to get ready for the January conference.

Where is Model Assembly?

Delegates live and work in the conference hotel in Minneapolis throughout the session.

The conference also utilizes the State Capitol Complex, including the State Capitol Building, Minnesota Judicial Center, State Office Building, and Minnesota Senate Building.

What is included in the state program fees?

Training and program preparation leading up to the conference, including the day-long LAUNCH training in November.

At the conference: 3 nights lodging, program transportation, security, meeting space rental, evening activities, supplies, program resources, and advisor costs.

Food is not included in program fees and is "on your own".

What is included in the local delegation fees?

Local delegation expenses - these vary by group.

Transportation to and from LAUNCH in November.

Transportation to and from Model Assembly.

How do hotel rooms work?

Students make roommate requests to their local delegation directors and are assigned to rooms with two double beds and up to three other students of the same gender identity. Groups

of more than four per room are not allowed. What is the role of adults?

Dedicated adult advisors help each local delegation organize, conduct trainings, raise funds, and prepare for Model Assembly. At the conference, adults are responsible for supervision, safety, and security.

How do the local delegations work?

A delegation is a group from a school, YMCA, or community group that is organized on the local level for participation in the program. Local delegations support and prepare youth for Model Assembly. Delegations can be of a variety of sizes and are led by youth and adults in partnership. All communication, financial arrangements, and preparation happen at the local delegation level.

MEALS & FOOD

All meals are "on your own" during the conference. Students will have access to a variety of food options for meals in the Minneapolis skyway system or near the Capitol Complex.

Many bring snacks and light breakfast items to eat in their hotel rooms. Skyways, buses, and restaurant areas are supervised by adult advisors. We help students identify healthy food options at the restaurants we patronize.

SAFETY AND SECURITY

Keeping students safe is our top priority. We gather YMCA staff, teachers, and volunteers to coach, support, and supervise students throughout our conferences.


- All volunteers undergo criminal background checks prior to the conference
- We hire a security company to staff the sleeping room floors in our hotels each night
- Adult Advisors supervise skyways and restaurants during every meal period
- Each delegation conducts a group check-in meeting before bedtime and enforces curfew with room checks each night

CODE OF CONDUCT & DRESS CODE

YIG programs promote a trust-based Code of Conduct. We expect that all delegates will conduct themselves in a mature and respectful manner. The Code outlines expectations for conduct and possible consequences for not following those expectations.

During program hours, everyone is required to wear business attire. During evening activities and other personal time, students are allowed to dress more casually. We don't expect students to buy new clothes to attend conferences – the dress code has a wide range of what is considered "business" attire.

WAYS TO PARTICIPATE AT MODEL ASSEMBLY

LEGISLATIVE BRANCH

Youth Representatives and Senators identify state issues important to them, their families, their schools, or their communities and write legislation to improve Minnesota. Delegates present their bills in committee hearings and on the respective House or Senate floor. Students work together to find solutions to some of Minnesota's biggest issues in a format that encourages respect and understanding.

NATIONAL ISSUES FORUM

Delegates prepare, present, and discuss important national issues with their peers in a forum that is focused on productive, respectful debate. Each student prepares a proposal on a topic relevant to current events.

LEADERSHIP CORPS

Students are introduced to each aspect of Model Assembly, have a chance to learn about the workings of state government, and participate in skill-building and leadership development activities. Students work in small groups, spend the weekend creating bills, arguing court cases, writing media articles, and getting exposure to all the program areas in order to kick off their Model Assembly careers.

JUDICIAL BRANCH

Court members prepare for hearings and make arguments before Youth Judges or Justices. Each student has the opportunity to argue both sides of their assigned case and will have an opportunity to serve on the bench.

Appellate Program – Youth lawyers make legal claims on issues related to citizen rights and responsibilities and application of constitutional law.

Trial Program – Students make legal arguments in civil or criminal cases – to determine guilt or innocence or establish legal facts and models the experiences of lawyers and judges in real-life court hearings.

OTHER MODEL ASSEMBLY OPPORTUNITIES

These positions are available to students after participating in their first conference. Students must apply during or immediately after the conference and be selected by the Elected Officers to assist in leading the various program areas for the following year. Officials attend a few prep sessions to meet their peers and learn about their specific roles.

Lobbyists provide testimony, draft bills to assist Youth Legislators, and represent one of more than 50 different organizations and corporations for which they concentrate their lobbying efforts – working together to support or oppose potential laws.

Media

Media participants are responsible for reporting, producing, or publishing on several news platforms each day – via TV Station, Radio Station, Newspaper, and Digital Media. They interact with all areas of Model Assembly and report their findings to all students and advisors at the conference – along with parents, donors, and alumni outside the conference.

Media Program Areas

Appointed by Elected Officers

Executive Branch

This branch consists of the Governors' Staff and Cabinet, as well as the Secretary of State's office. The Youth Governor and Lt. Governor identify officials to help advance their legislative and leadership agendas. The Youth Secretary of State's staff tracks pending legislation and conducts conference elections for the next year's youth leaders.

MODEL ASSEMBLY LEADERSHIP ROLES

Youth leadership is the core of Model Assembly programs. The program is conducted and led almost entirely by students. Participants have opportunities to serve as up-front leaders elected by their peers or as officials who are appointed to help carry out program functions.

Elected Officers – These leadership positions are determined at the end of the conference the preceding year. Students who are elected make a year-round commitment to Model Assembly and to the students they serve. Candidates stand for election for one of about 20 leadership roles for the following year's conference.

Appointed Officials – These students are in specialty roles selected by the Elected Officers to assist in leading the various program areas. Leading up to Model Assembly, students attend various trainings where they prepare for and learn about their specific roles. Application for these roles concludes shortly after Model Assembly adjourns.



OTHER EXPERIENCES

MODEL UNITED NATIONS (MUN)

This program creates a working replica of the United Nations. Students can participate in a model General Assembly, International Court of Justice, Economic and Social Council, Security Council, Human Rights Council, or Conference Media. While focusing on role-playing an "adopted" country, participants exercise the arts of compromise and diplomacy to attempt to solve pressing global problems.

- Open to students in grades 7-12
- Model UN takes place in late March/Early April each year
- Registration begins in December

NATIONAL JUDICIAL COMPETITION (NJC)

NJC is a chance for YIG participants to expand on the legal issues they explore in Minnesota's state session and to meet fantastic delegates from other states. This five-day conference takes place during late July in Chicago and includes time for fun group activities before the actual trials begin.

- Open to students in grades 10 12
- Applications for NJC are due in February
- Participation in MAS or MUN is required to apply


YOUTH CONFERENCE ON NATIONAL AFFAIRS (CONA)

More than 600 participants from about 40 states are selected to attend the conference where they debate issues of national and international importance. The 12-day trip happens in early July at the YMCA Blue Ridge Assembly. The Minnesota delegation takes an exciting post-conference trip to various east coast cities, which have included Washington, DC, and New York City. This is an amazing opportunity to have conversations on a national scale, meet students from around the country, and have a life-changing experience.

- Open to students in grades 10 12
- Applications for National Affairs are due in February
- Participation in MAS or MUN is required to apply

HOW TO REGISTER

- Register online at mnyig.org
- Registration is a 2-step process and is not complete until second step is finished by the student
- Each delegation has a different program fee see the local Delegation Director for specifics
- Each registration must be accompanied by the required deposit. The completed registration process, along with the deposit, will secure your place at Model Assembly.

PAYMENTS AND CANCELLATIONS

- **Cancellations may be made until December 2**, when all fees and rosters are final. The deposit is not refundable at any time. Once a payment date has passed, that amount is non-refundable and non-transferrable, but any future fees due will be waived.
- All fees are due December 3 unless you have a preapproved payment plan established. If you have questions about payment plan policies, please contact your local Delegation Director. The Delegation Director will work on this with the State Office.
- Cancellations must be in writing and are submitted to the local Delegation Director.
- If a delegate has a significant discipline issue or violation of the Code of Conduct, we reserve the right to dismiss the delegate, without refund, for the remainder of the session.

FINANCIAL ASSISTANCE AVAILABLE

- The YMCA is committed to providing access to all who wish to participate in our programs. Need-based financial assistance is available giving those who are eligible between 10% and 50% off. We raise funds through the Annual Fund to help make that possible. Financial Assistance is granted on first-come, firstserved basis. Please visit mnyig.org for an application. Apply to your local delegation director by **December 2**. Incomplete applications will be returned.
- Some requesting Financial Assistance may not be able to complete their registrations online. Please check with your Delegation Director for more information.

ACCESSIBILITY

Students with disabilities requiring an accommodation or some special need program leaders should be aware of, please contact the local Delegation Director. The Delegation Director will work with the YIG State Office related to the request. This information enables us to better meet the needs of students within available resources. For students requiring special accommodations, decisions are made on a case-by-case basis.


